Industry risk-based analysis

2022-2023 completed research:

- Mining sector surface diamond drilling risk assessment
- <u>Surface diamond drilling root-cause analysis on</u> <u>emergency response time</u>
- <u>Corrugating sector root cause analysis on pedestrians</u> <u>struck by mobile equipment</u>
- Silviculture risk assessment focused on driving hazards
- Logging risk assessment focused on highway travel

Research results provide a strong basis for prioritizing industry needs, training and resources.

Programs developed because of research

In 2022-2023 WSN continues the implementation of two Chief Prevention Officer-approved programs to support the results of risk-based workshops.

Safe Driving on Forest Roads training course, which helps the logging sector address its greatest risk 'distracted driving,' is now available in French.

Lockout-tagout (LOTO) - This high-risk task which significantly affects the resource sector was explored in detail by a multi-sector advisory committee. They recommended the content for a LOTO program workplace assessment tool. The tool is currently being used by WSN staff to conduct on-site LOTO workplace assessments. Aggregate data from these assessments will be used to guide the development of a LOTO train-the-trainer program.

Psychological Health and Safety Project

Funding for the three-year workplace mental health (MH) project is being used to develop and deliver in-person and online training programs for mining and forestry operations, including an online portal where workers and employers can access mental health tools and resources 24-7, as well as free resources and awareness sessions for small businesses.

Training Initiatives

Expanded offerings include JHSC Part 1 e-learning, JHSC Refresher training in French, which completes the WSN suite of full French JHSC training (Part 1, 2 and Refresher).

Promotion of Health and Safety Representative training and its offer to employers at no cost and paying them \$150 for an employee's successful completion of the program.

Required annual refresher training for Working at Heights and JHSC conducted via third-party trainers' completion of questionnaires related to program material and their experience as trainers. This also provides WSN ongoing feedback from its trainers and confirms continued understanding of program requirements as well as consistency of program presentation.

In addition to its extensive training catalogue, WSN developed and introduced the following updates.

- Expanded French-language programming to include Safe Driving on Forest Roads.
- Introduction to Professional Chainsaw Operation (IPCO) and Introduction to Professional Chainsaw Operation Train-the-Trainer, and significant enhancement to the Cutting Edge manual and IPCO Train-the-Trainer. These significant changes were shared with training partners through refresher training sessions. This represents the most significant update to the WSN suite of chainsaw training programs in the past several years.
- Mining Supervisor Common Core training suite is under review with the Mining Supervisor Common Core.
- Updated Auxiliary Mine Ventilation manual for mining industry and to support WSN Mining Supervisor Common Core, Mine Ventilation training.

- Competent Supervisor Training programs both classroom and virtual have been updated and in response to requests from past training program participants we have developed a Competent Supervisor Refresher Training programs.
- Continued enhancement to WSN virtual training offerings, ensuring they all meet program development criteria, plus enhanced internal training for virtual trainers to ensure the highest level of quality and consistency in WSN training. WSN also initiated exploring expanding our training offerings to include a hybrid training format.
- **Promotional videos** produced for new WSN Excellence Canada recognition video and WSN Mining Health and Safety Conference.
