
Updated manual at the start of this year.

WSIB Health and Safety Assessment

When accessing the WSIB portal for the first time and prior to selecting topics, you will be required to complete the **HSEp Health and Safety Assessment**.

Online questionnaire to help identify gaps in your current health and safety program and the topics your business still needs to develop.

Quick and easy to complete!

Based on responses, the system assigns your business to a program level and generates a list of recommended health and safety topics.

Recommended topics are not mandatory.

Topic Requirements

Each topic in the three levels will have topic requirements that must be included with the submission to the WSIB and included on the portal.

You will not get approved for any topic that does not include all the requirements.

Timelines for the HSEp Process

From the day your topics are approved by your WSN Health and Safety Specialist, you will have 365 days to submit your evidence for validation using the portal.

You can submit earlier but will need time to gather evidence and demonstrate that the topic is living and breathing.

Once you submit, if the validator marks it as **Additional Evidence Required**, you will have 60 days to provide that additional evidence.

If your topic submission is successful, you will receive a rebate from WSIB.



HSEp Timelines

Step One

- Register with WSN
- Pay WSN invoice
- Register with WSIB and the portal
- Complete the health and safety assessment

Step Two

- Review topics and requirements
- Select topics
- Get approval from senior management
- Enter the topics into the WSIB portal
- WSN approves the topics clock starts



HSEp Timelines (Based on Five Topics)

Within 6-9 Months

Step Three

Develop material for Topic 1

Step Four

- Develop material for Topic 2
- Gather evidence for Topics 1-2

Step Five

- Develop material for Topic 3
- Gather evidence for Topics 1-3

Step Six

- Develop material for Topic 4
- Gather evidence for Topics 1-4

Step Seven

- Develop material for Topic 5
- Gather evidence for Topics 1-5



HSEp Timelines

Final 1-3 Months

Step Eight

- Combine all evidence per topic into one PDF file
- Develop evidence story for submission

Step Nine

- Forward all files to WSN HSS to review
- Update material as necessary

Step Ten

- Upload all evidence and evidence story into WSIB portal
- WSN submits for validation



Choosing Topics and the Action Plan

New for 2025

Topics selected must be new to the organization.

Template 1 (rationale for topic selection) is no longer required.

Action Plan

WSIB's action plan is selecting topics.

WSN's action plan is utilizing Template 2 to set up a plan on getting to the finish line and being successful.

Template 2 is not required to be uploaded to the portal, but WSN strongly recommends you do so to show concrete plan of action to validator.



Control of Hazards (Topic Focus)

Control of Hazards is a unique topic (two routes)

Control of Hazards Basic

Topic where you develop a generic control of hazard requirements.

Control of Hazards (Specific)

Cover a variety of workplace-specific topics.

Lockout, Guarding, MSDs, Confined Space, Working alone, etc.



Control of Hazards

Control of Hazards (Specific)

You can do this topic repeatedly (focusing on different hazards).

These topics must be new to your workplace.

For firms with 1-99 employees (exemption)

You are addressing a hazard that hasn't been controlled.

You are implementing new control measures.



Considerations for Control of Hazards

Members can't use this topic to control the same hazard in different ways.

Members must describe control measures using the hierarchy of controls.

Members must apply the control measures they develop in the topic to all areas of their business where the hazard is present.

Members must show how they'll monitor implemented controls to ensure they're working as intended.



Tips for Validation Success (Control of Hazards)

Does the submission describe how the hazard(s) was not controlled?

Does the submission demonstrate application of the hierarchy of controls?

Does the submission describe existing and new control measures?

Were existing and new control measures evaluated for effectiveness?



The WSIB Digital Tool

Once you register with Workplace Safety North:

Rose Bedard will provide you with a link to the WSIB online portal.

You will create a user account.

Complete the workplace assessment

This will gauge your involvement in health and safety and provide you with a program level.

A list of recommended topics will be provided (not mandatory).

Work with your Health and Safety Specialist to select topics and get them approved.




