

Minutes Annual General Meeting September 25, 2019

The 9th Annual General Meeting of the members of Workplace Safety North was held at 5:45 pm on Wednesday, September 25, 2019 at Churchill's Restaurant, North Bay, Ontario.

Sandra Haddad, Chair, WSN Board of Directors, welcomed all and thanked everyone for their attendance.

1. CALL TO ORDER

S. Haddad confirmed that a quorum is present, with twenty-four voting members and zero proxies, and that the meeting was duly constituted for the transaction of business.
